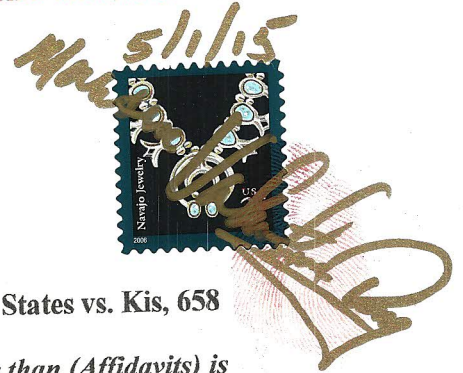

JUDICIAL NOTICE
